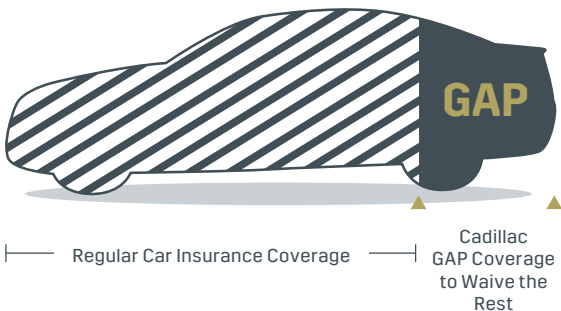


PROTECT WHAT YOU'VE EARNED

If something happens and your Cadillac is considered a total loss, your standard insurance will pay only the current market value. Your insurance may not pay what is owed on your Cadillac or your insurance deductible, which creates a gap. Cadillac GAP Coverage can help cover that gap, including the insurance deductible. HOW CADILLAC GAP COVERAGE WORKS





GUARANTEED AUTO PROTECTION

GAP Coverage waives the deficiency amount between your Cadillac's unpaid finance balance and the settlement amount offered by your insurer.

COVERED FROM THE START

GAP Coverage is only available at the time of Cadillac purchase.

FLEXIBLE

GAP Coverage is available for your new, used, or leased Cadillac.

FINANCIAL PEACE OF MIND

GAP Coverage is available for finance amounts up to \$125,000.

WORRY-FREE ENDORSEMENT

GAP Coverage can waive your financial loss up to \$75,000, which includes up to \$1,000 of your insurer's physical damage deductible.

LENGTH OF COVERAGE

GAP Coverage is available for up to 84 months.

PROTECTS YOUR INTERESTS

GAP Coverage helps protect you against owing money on a Cadillac you can no longer drive.

REFUNDABLE

GAP Coverage can be canceled at any time. Your coverage is fully refundable within 60 days, as long as no losses have occurred. For cancellations after 60 days, a pro rata refund will be given, less any applicable cancellation fee. All charges will be refunded to the financial institution/lender.

EXCLUSIONS*

- Losses occurring prior to the effective date of the GAP Addendum
- Losses caused by theft, unless you or your financial institution/lender file a police report
- Any loss that falls outside the standard or optional equipment available from the manufacturer of the covered vehicle
- Vehicles used for commercial purposes
